### Rules applied for the 2006 Virtual Fair

The Fair's Virtual Shopping Mall (the VSM) will last 5 days; from June 5th up to an including June 9th. All registration forms duly completed must be forwarded before Thursday June 1st.

The stands will be assigned on the basis of first come, first served. The Canadian Practice Firm Network (CPFN) will deliver a 50 000\$ CAN spending budget to each participating firm. A 3% administration fee will be charged on each and every transactions. Take notice that all transactions are definitive; no cancellation will be allowed.

The spending limit of every enterprise is determined by the amount it was granted for the fair. The purchases of an enterprise can not exceed its asset. No transaction should take place if the funds are not available. It is the enterprise's responsibility to inform their participants of this important rule.

You can advertise in the trade fair's journal once a day, on half a page (photos and text included). If you choose to display your own publicity, the e-mail must not weigh over 250k.

Odyssee Québec-Monde will provide the information and the procedures to have access to the site of the fair. The enterprises will take the responsibility to display their own products within the fair's site.

The logo image will be of 150 by 95. The product's pictures will be of 150 by 150 pixels. They should be sent to Kerby Noël of Plasmont International Inc.. He can be reached at the following address : [adnoel@plasmont.com](mailto:adnoel@plasmont.com). Plasmont will convert your file in the appropriate format and the enterprises will then verify if it is convenient for them.

When a purchase is carried out, the supplier receives an order form and the client a confirmation of the order. The supplier will transmit a delivery slip and a bill to the client's enterprise, as usual. This bill will be paid with a check or a money order, as any other bill.
